Overview

Assessment and Verification

All units in this qualification are assessed and internally quality assured by UK Versity and externally verified by OTHM. Assessments are based on meeting specific learning outcomes. Learners must present evidence demonstrating they have achieved all intended learning outcomes. Assessors will review and judge submissions using established assessment criteria. Learners receive clear guidance via assignment briefs and grading rubrics.

Assessors are responsible for maintaining transparent records documenting how learners' achievements were evaluated and validated. Course Material -Learners will receive access to course materials including presentations, e-books, handouts, and assignments. A course handbook and tutor-led guidance are also provided via email and the online platform. Online Learning -This course is self-paced with monthly tutor interaction. Although progress is encouraged regularly, learners can complete their studies flexibly over the academic period.

Progressions -Graduates of the OTHM Level 4 Diploma in Cyber Security can progress to the OTHM Level 5 Extended Diploma in Cyber Security or similar qualifications in computing and information systems. The Ofqual recognition enables direct consideration for entry into the second year of a UK Bachelor's degree programme in a related field.

Course Material

Course material, including presentations; handouts, assignment briefs and e-books are made available to enrolled learners. In addition to this, the learners also get the course handbook and tutorial via emails to support the learning.

Online learning

The learner sets the pace for learning and the courses are offered across an academic year basis. Although our tutors encourage the learners to make progress monthly, but this approach is flexible.

Progressions

Successful completion of the OTHM Level 3 Certificate in Python provides learners with opportunities to progress to the OTHM Level 4 Diploma in Cyber Security, Level 5 Extended Diploma in Cyber Security, or equivalent qualifications in programming, data science and software development.

As this qualification is approved and regulated by Ofqual (Office of the Qualifications and Examinations Regulation), it is recognised by many UK universities and institutions. Learners may be eligible to apply for undergraduate programmes related to IT and computing.
